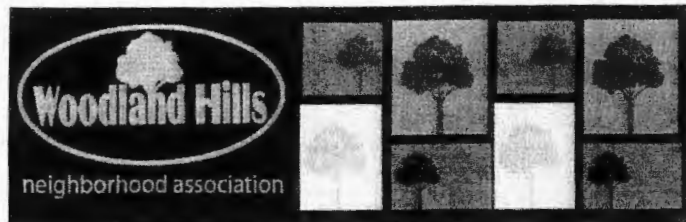

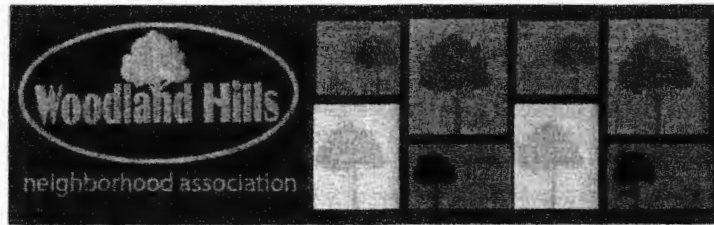

My name is Tom Woodward. I am the 2012 President of Lindbergh LaVista Corridor Coalition (LLCC), a local 501(c)(3) nonprofit organization. We're excited to inform you that your membership in the Woodland Hills Neighborhood Association includes an associate membership in LLCC. I'd like to welcome you on behalf of our Board of Directors, as well as give you some information about who we are and how we can help you.

LLCC was formed five years ago to work on behalf of Lindridge Martin Manor, LaVista Park, and Woodland Hills neighborhoods, as well as area businesses, serving as a community advocate, long-term planner and fundraiser. LLCC works with your neighborhood association to invest in our broader community and bring neighborhoods and area businesses together to provide a stronger voice supporting community preservation and improvement.

To this end, we completed our *Blueprints for Successful Communities Study* four years ago and are working with Perkins+Will, an international urban design firm, since then to implement study recommendations. They are helping us decide which elements of the study can be made "real" and are working with us to develop a strategic plan for implementation. Some areas of focus in the study included neighborhood preservation, transportation/connectivity, green space, and the enhancement of our business community.

We have worked with South Fork Conservancy to develop green space in the form of a new trail system along Peachtree Creek, with neighborhood volunteers on monthly litter pickups along Lindbergh and LaVista Roads, sponsored annual electronics recycling programs, and assisted in the planning of the annual "Taste & Tour on Cheshire Bridge," among other accomplishments.

To further the efforts of our Coalition, we need additional funds for operations and seed money for grant applications. The average grant requires that we provide at least a 10% match. Your additional tax-deductible contributions of \$20 or \$50 will go a long way toward helping us reach the goals we've set to improve our community. You can make this additional contribution by including it with your membership dues to WHNA or by visiting our website at [www.lindberghlavista.org](http://www.lindberghlavista.org). Please note that in order to receive the tax deduction, you will need to write a *separate* check made payable to "LLCC."

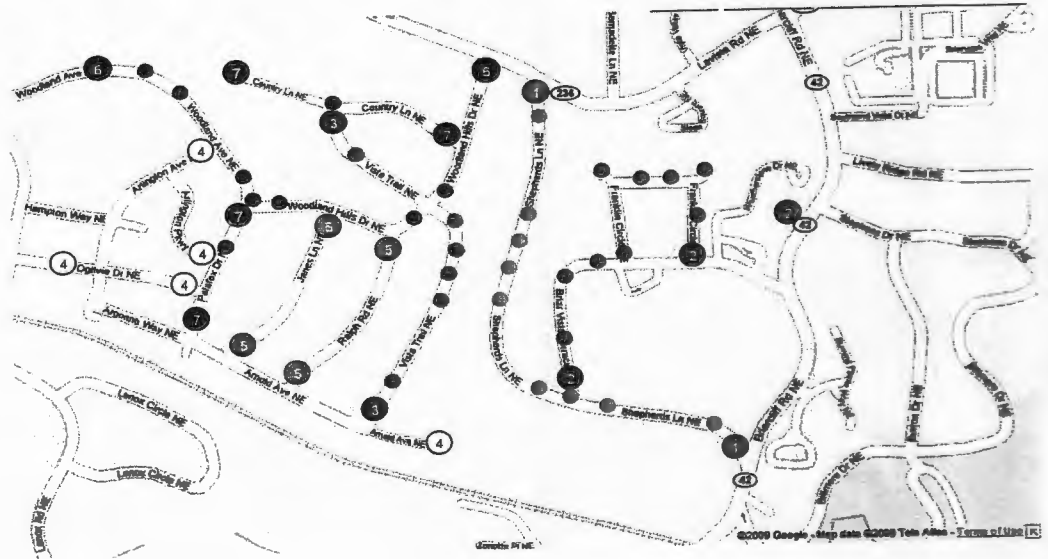

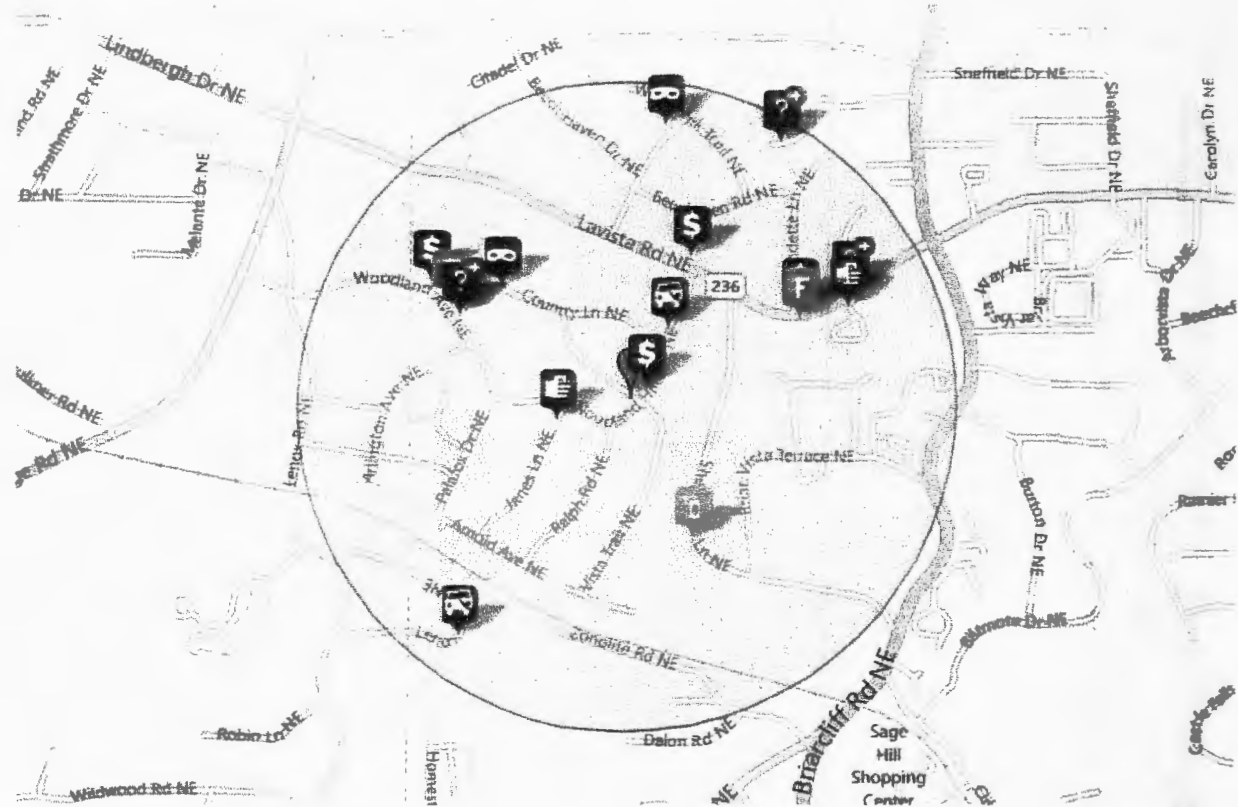
